**“ A prescription for a controlled substance to be effective must be issued for a legitimate medical purpose by an individual practitioner acting in the usual course of his professional practice. The responsibility for the proper prescribing and dispensing of controlled substances is upon the prescribing practitioner, but a corresponding responsibility rests with the pharmacist who fills the prescription. ”**

**SCOPE OF AUTHORITY - A dentist may prescribe, administer, or dispense a controlled substance only:**

**1. In good faith in the course of the dentist's professional practice**

**2. Within the scope of the dentist-patient relationship**

**3. In accordance with treatment principles accepted by a responsible segment of the profession**

**Prescribing in Exchange for Street  
Drugs or Sex (Never for Economic  
Reason)**

**Calling In or Writing a Prescription  
Using a Different DEA Number**

**Violation of Title 21, United States Code  
841(a)(1)**

# **CRIMINAL ACTIONS**

## **Self-Prescribing for Personal Use (Pain vs. Addiction)**

- Outside of Professional Practice**
- No Doctor-Patient Relationship**
  - No Treatment Plan**
- Prosecution on a State Level for violation of their Controlled Substances Act**

# **CIVIL ACTIONS**

**No Dispensing or Purchasing  
Records for Controlled Substances  
Obtained for Office Use**

**- Subject to up to a \$10,000 fine**

**Violations of Title 21, United States Code 842 (a)(5)  
and (a)(10)**

# **ADMINISTRATIVE ACTIONS**

- Surrender of a DEA Registration**
- Surrender of a State Medical License**
- Memorandum of Understanding**
- Letter of Admonition**
